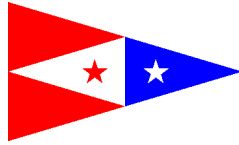

## Hart Nunes Regatta June 29-30, 2024

### NOTICE OF RACE

**Organizing Authority: The San Francisco Yacht Club, Belvedere, California**

#### **1 RULES**

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 Rule 40.1 will apply at all times when boats are in the racing area, and on their way to and from the racing area.

#### **2 SAILING INSTRUCTIONS**

The sailing instructions will be available by 1600 hours on June 26 on The San Francisco Yacht Club website at [www.sfyc.org](http://www.sfyc.org) and at the Competitors' Meeting.

#### **3 COMMUNICATION**

- 3.2 On the water the race committee will make courtesy broadcasts to competitors on VHF radio channel USA 65A.
- 3.3 While racing, except in an emergency or when retiring from a race, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### **4 ELIGIBILITY AND ENTRY**

- 4.1 The regatta is open to all Mercury Class sailboats. This regatta will be a counter in the Travel Trophy Series.
- 4.2 Eligible boats may enter online at [www.SFYC.org](http://www.SFYC.org) under On the Water > Regattas and pay by credit card, by 1600 hours on June 28.
- 4.3 The entry fee is \$80. A late fee of \$40 will be charged after 1600 hours on June 26.

#### **5 RACE SCHEDULE**

Six races are scheduled, three each day.

**6 VENUE**

The racing area will be in Richardson Bay, or alternatively Raccoon Strait or Knox depending on conditions and forecast.

**7 COURSES AND MARKS**

The courses and marks will be described in the sailing instructions, and will be windward-leeward type.

**8 PENALTY SYSTEM**

Appendix V1 (Penalty at the Time of an Incident) shall apply.

**9 SCORING**

A boat's series score will be the total of her race scores. No scores will be excluded.

**10 RISK STATEMENT**

Competitors participate in the event entirely at their own risk and subject to the terms and conditions of the SFYC liability waiver.

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

**11 PRIZES**

The Hart Nunes Perpetual Trophy will be awarded to the winner of the regatta. Keeper trophies will be awarded to the top three boats.
