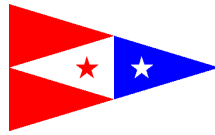

## SUMMER KEELBOAT REGATTA

August 7 - 8, 2021

### NOTICE OF RACE

**Organizing Authority: The San Francisco Yacht Club, Belvedere, California**

#### **1 RULES**

- 1.1 This regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 For the J/105 fleet the J/105 Fleet One rules shall apply.
- 1.3 Rule 40.1 will apply at all times when boats are in the racing area, and on their way to and from the racing area.

#### **2 SAILING INSTRUCTIONS**

The sailing instructions will be available by 1800 hours on August 4 on the website [www.sfyc.org](http://www.sfyc.org).

#### **3 COMMUNICATION**

- 3.1 The official notice board is located on the west wall of the SFYC clubhouse. Notices, other than those related to hearings, will also be posted online at [www.sfyc.org](http://www.sfyc.org). Hearing requests and notices will be posted online, as described in the sailing instructions.
- 3.2 On the water the race committee will make courtesy broadcasts to competitors on VHF radio channel USA 65A.
- 3.3 From the first warning signal until the end of the last race of the day, except in an emergency, or when retiring from a race, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### **4 ELIGIBILITY AND ENTRY**

- 4.1 The regatta is open to the following classes:  
J/105, Express 37, J/88, Melges 24, J/70, Express 27 (Sunday only), J/24.
- 4.2 Eligible boats may enter by completing the online registration found at [www.sfyc.org](http://www.sfyc.org) > On the Water > Regattas.
- 4.5 No entries will be accepted after 1700 hours on August 6.
- 4.6 If fewer than 5 boats in a class are entered by 1700 hours on August 4, SFYC may refund their entry fees and not provide a start for that class.

#### **5 FEES**

The entry fees are as follows, if received by 1700 hours on August 4. A \$50 late fee will be charged after 1700 hours on August 4.  
Express 27 - \$70 (Sunday only)

J/70 - \$120  
Melges 24, J/24 - \$140  
J/105, Express 37, J/88 - \$160

## **6 SCHEDULE**

Saturday – Three (3) races are scheduled with the first warning signal at 1200 hours.

Sunday – Two (2) races are scheduled with the first warning signal at 1200 hours. No warning signal will be made after 1530 hours.

## **7 VENUE**

The racing area will be in the vicinity of the Berkeley Olympic Circle.

## **8 COURSES**

The courses and marks will be described in the sailing instructions. All marks will be inflatable buoys.

## **9 PENALTY SYSTEM**

9.1 Appendix V1 (Penalty at the Time of an Incident) shall apply.

9.2 For the Melges 24 Class, rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

## **10 SCORING**

10.1 Two races must be completed to constitute a series.

10.2 A boat's series score will be the total of her race scores. No scores will be excluded.

## **11 BERTHING**

SFYC guest docks will be available on a first-come-first-served basis from August 6 through August 8.

## **12 RISK STATEMENT**

Competitors participate in the event entirely at their own risk and subject to the terms and conditions of the SFYC liability waiver.

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury.

**Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

## **13 INSURANCE**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$100,000 per incident or the equivalent.

## **14 PRIZES**

Prizes will be awarded depending on the number of entries.
